STAFF SERVICE CIRCULAR NO. 9/2023

REVISED EXEMPTION CRITERIA OF THE BASIC TEACHING METHODOLOGY COURSE (BTMC) FOR ACADEMIC STAFF APPOINTED ON PERMANENT AND CONTRACT BASIS

1. OBJECTIVE

The objective of this circular is to inform all Deans/Directors of the Kulliyyahs / Divisions / Centres / Institutes / Offices / Mahallahs pertaining to the revised exemption criteria of the Basic Teaching Methodology Course (BTMC) for academic staff appointed on permanent and contract basis.

2. BACKGROUND

- 2.1 All newly appointed academic staff of IIUM must undertake the BTMC course as stated in the letter of appointment.
- 2.2 BTMC is a designated programme to all academic staff in order to expose participants to selected aspects of teaching methodology to make them better instructors, to heighten their knowledge, skills and attitudes towards good instructional practices and to motivate them to constantly strive for excellence in line with the University's vision and mission.
- 2.3 Currently, BTMC is under the purview of the Centre for Professional Development (CPD), the centre that is responsible to organize and facilitate compulsory training for newly recruited academic staff, and needed-based professional development training for academic staff in IIUM at all stages of their careers.
- 2.4 CPD has received several applications for full BTMC exemption from academic staff with professor positions and those who have been teaching at the tertiary level for more than ten (10) years.
- 2.5 The exemption criteria for BTMC is revised to suit the current needs and to ensure the effective support for the teaching and learning activities in the Kulliyyahs / Divisions / Centres / Institutes.

























3. DECISION

- 3.1 The Staff Service Committee (SSC) Meeting No. 1/2023 held on 28th March 2023 approved the following:
 - i) It is compulsory for Academic Fellow to successfully complete the BTMC as part of requirement for service. However, Academic Fellow may also apply for exemption subject to the same criteria imposed to other Academic staff.
 - ii) The current term of teaching practicum is to be known as Teaching Observation.
 - iii) Participants who fail BTMC will be allowed to repeat BTMC only once. Further action should be taken by MSD for those who did not pass BTMC after the second attempt.
 - v) The exemption of TIDE and BTMC is extended to academic staff currently serving the University and appointed to another academic scheme of service such as Matriculation/CELPAD Teacher/Lecturer (Grade DG) to Assistant Professor (Grade DS) as modules for TIDE and BTMC are the same for all academic staff, regardless of scheme of service, subject to the following:

- 3.2 The Staff Service Committee (SSC) Meeting No. 4/2002 and No. 1/2023 held on 22nd December 2022 and 28th March 2023 respectively approved the revised BTMC exemption criteria as in *Appendix A*.
- 3.3 The effective date of implementation is 1st January 2023.
- 3.4 With the implementation of the above revised exemption criteria of the BTMC for academic staff appointed on permanent and contract basis, the MSD Service Circular No. 3/2020 is superseded.

All Deans/Directors are kindly required to disseminate this information to all relevant staff at the Kulliyyah/Centre/Division/Institute/Offices/Mahallahs.
