### STAFF SERVICE CIRCULAR NO. 14/2023

# EARLY PAYMENT FOR CASH COMPENSATION OF UNUTILISED ANNUAL LEAVE (IIUM GOLDEN HAND SHAKE)

#### 1. **OBJECTIVE**

The objective of this circular is to inform all Deans/Directors of the Kulliyyahs / Divisions / Centres / Institutes / Offices / Mahallahs pertaining to the early payment for cash compensation of unutilised annual leave (IIUM Golden Hand Shake).

#### 2. **BACKGROUND**

a)

- The Government through its Service Circular Letters Ref. No.: JPA/PEN/228/15/2 (26) and JPA/PEN/228/26/6-13 LJD. 5 (29) agreed to revise total days of accumulated Annual Leave to be used in retirement year and early payment for cash compensation of unutilised Annual Leave from the accumulated IIUM Golden Hand Shake effective 1st January 2023 as follows:
  - Amendment to PP.1.3.1: Cash Compensation of Unutilised Annual Leave - Increased the total days of accumulated annual leave for cash compensation from 150 days to 160 days effective from 1st January 2022 and to 180 days effective from 1st January 2023.
  - Amendment to PP.1.3.4: Early Payment for Cash Compensation of Unutilised **Annual Leave** 
    - Implementation of early payment for cash compensation of unutilised annual leave of 80 days effective from 1st January 2022 and to 90 days effective from 1st January 2023 which includes the specific requirements and procedure.

















## 3. DECISION

- 3.1 The Staff Service Committee (SSC) Meeting No. 1/2023 and No. 2/2023 held on 28<sup>th</sup> March 2023 and 13<sup>th</sup> June 2023 respectively, agreed to adopt the Amendment to PP.1.3.4: Early Payment for Cash Compensation of Unutilised Annual Leave (IIUM Golden Hand Shake) with some modifications as follows:
  - i) The eligibility criteria:
    - a) Administrative and Technical staff in the support group category (Grade 3-40);
    - b) Has been serving not less than fifteen (15) years (excluding unpaid leave/half-pay leave);
    - c) Age between 45 years to 49 years old;
    - d) The total of unutilised Annual Leave accumulated prior to the initial application of the IIUM Golden Hand Shake cash compensation shall be at least 90 days; and only fifty (50) days from this total can be allowed for early payment of cash compensation;
    - e) Not involved in any criminal proceedings or disciplinary cases;
    - f) Recommended by the Head of Department/Dean/Director; and
    - g) The early payment is for the purpose of education, medical reason or any urgent matters subject to approval by the University Authority.
  - ii) The Early Payment for Cash Compensation of Unutilised Annual Leave (IIUM Golden Hand Shake) is extended to other grades of other schemes of services and subject to the above criteria (b) (f). However, the early payment is for the purpose of **medical reason only.**
  - iii) The application of Early Payment for Cash Compensation of IIUM Golden Hand Shake can be made to Management Services Division as attached herewith.
  - v) The approving authority is the Executive Director, Management Services Division.
  - vi) The formula of calculation of the GHS shall be in accordance to the formula currently in force.
- 3.2 The effective date of the of implementation of the above said decision is 1<sup>st</sup> January 2023.

All Deans/Directors are kindly required to disseminate this information to all relevant staff at the Kulliyyah/Centre/Division/Institute/Offices/Mahallahs.
