STAFF SERVICE CIRCULAR NO. 17/2023

IMPROVEMENT OF UNRECORDED LEAVE FACILITY FOR TAKING PART IN SPORTS ACTIVITIES

- a) A staff member who is to take part in sports activities at the state or international level may be given unrecorded leave for a period of not more than (30) days only; and
- The leave will be given based on prerogative of the Head of Department and b) subject to exigency of service.
- 2.2 In accordance with the current changes and importance of sports development, the Government has agreed to improve the Unrecorded Leave Facility for Taking Part in Sports Activities for government officials who are involved in sports competitions at the National and/or International level.







## 3. DECISION

- 3.1 The Staff Service Committee (SSC) Meeting No. 2/2023 held on 13<sup>th</sup> June 2023 agreed to adopt the amendment of the SR5.5.1 on the Unrecorded Leave Facility for Taking Part in Sports Activities with some modifications as provided in *Appendix A*.
- 3.2 The effective date of implementation is 13<sup>th</sup> June 2023 i.e. the date of SSC Meeting which endorses the decision.
