STAFF SERVICE CIRCULAR NO. 19/2023

IMPROVEMENT OF 'PAKAIAN ISTIADAT' BENEFITS FOR ATTENDING OFFICIAL FUNCTIONS

1. OBJECTIVE

The objective of this circular is to inform all Deans/Directors of the Kulliyyahs / Divisions / Centres / Institutes / Offices / Mahallahs on the Improvement of '*Pakaian Istiadat*' Benefits for Attending Official Functions.

2. BACKGROUND

- 2.1 The Staff Service Committee (SSC) Meeting No. 1/2008 on 21st January 2008 (previously known as Staff Service Board) had adopted the following circulars related to the payment of 'Pakaian Istiadat':-
 - Government Service Circular No. 16/2007 on Payment for 'Pakaian Istiadat', Assistance Payment for Black Tie Suit and Payment of Suit for attending official functions; and
 - b) Government Service Circular Letter No. 15/2007 on Guidelines on Implementation of Payment for '*Pakaian Istiadat*', Assistance Payment for Black Tie Suit and Payment of Suit for attending official functions.
- 2.2 Recently, through the Public Service Department's Letter Ref. No.: JPA.(S) 800-1/1/14(24) of SR.1.2.2 on the Improvement of Payment of 'Pakaian Istiadat' Benefits to Civil Service Officer.

















3. DECISION

- 3.1 The Staff Service Committee (SSC) Meeting No. 2/2023 held on 13th June 2023 agreed to adopt the SR.1.2.2 on the Improvement of Payment of 'Pakaian Istiadat' Benefits for Attending Official Functions accordingly. Details are provided in Appendix A.
- 3.2 The effective date of implementation is 1st January 2023. With this adoption, SR.1.2.2 has superseded the Government Service Circular No. 16/2007 and Government Service Circular Letter No. 15/2007.

All Deans/Directors are kindly required to disseminate this information to all relevant staff at the Kulliyyah/Centre/Division/Institute/Offices/Mahallahs.

| 1 | Interpretation | i. "Pakaian Istiadat" refers to a formal ceremonial dress specially designed for a service. |
| | | ii. "Black Tie Suit" refers to semi-formal western attire worn for a dinner's occasion. The component of Black Tie Dress for female staff is the <i>baju kurung/kebaya</i> along with a scarf or evening dress including handbag and shoes. |
| | | iii. "Suit for Attending Official Function" means National or Dark Dress Lounge Suit for men or appropriate clothing for women when required to attend official ceremonies to receive stars or medals in Majlis Federal/State Star and Medal Awarding Ceremony or on official duty at Parliament or State Assembly. |
| | | iv. "Officer's Spouse" for the purpose of attended official ceremonies refers to the husband or wife of the staff. |
| 2 | Eligibility | i. Staff who have 'Pakaian Istiadat' are eligible to be given a Payment of 'Pakaian Istiadat' and may choose for the Payment of Suit for Attending Official Functions. |
| | | ii. Staff who does not have 'Pakaian Istiadat' but required to attend official ceremonies to receive stars or medals in Majlis Federal/State Star and Medal Awarding Ceremony or on official duty at Parliament or State Assembly are eligible to be given a Payment of Suit for Attending Official Functions. |
| | | iii. Spouses of the staff who are also present to attend official ceremonies to receive stars or medals in Majlis Federal/State are eligible to be given a Payment of Suit for Attending Official Functions. |
| | | iv. Staff on Grade 41 and above and Operational Group on Grade 29 to 40 who are assigned to serve in Parliament of the State Legislative Assembly is eligible for the Payment of Clothing for Attending Official Functions. |
| | | v. Staff who are required to wear the 'Pakaian Istiadat' while attending the official ceremonies is eligible for Assistance Payment for Black Tie Suit. |
