### STAFF SERVICE CIRCULAR NO. 4/2023

# ADOPTION OF THE TREASURY CIRCULAR 1PP - WP1.10 (REVISION EFFECTIVE ON 1<sup>ST</sup> JANUARY 2022) WITH REGARDS TO THE ALLOWANCE ELIGIBILITY WHILE ATTENDING COURSES

#### 1. **OBJECTIVE**

The objective of this circular is to inform all Deans/Directors of the Kulliyyahs / Divisions / Centres / Institutes / Offices / Mahallahs on the adoption of the Treasury Circular 1PP -WP1.10 (Revision Effective on 1st January 2022) with regards to the Allowance Eligibility While Attending Courses.

#### 2. **BACKGROUND**

- 2.1 At present, the provision on allowance eligibility while attending courses is based on the rate stipulated in the Treasury Circular 1PP - WP 1.10 as approved in the Staff Service Committee Meeting No. 4/2020 dated 14th September 2020 which took effect from 1st October 2020.
- Recently, the Treasury Circular has been revised through Treasury Circular No. 1PP -WP 1.10 (Revision effective on 1st January 2022). Among the revised item are as follows:
  - a) Increased rate of Food Allowance, Hotel Rental and Lodging Allowance;
  - The abolishment of equivalency grade to the salary grades available under b) Malaysian Remuneration System (MRS); and
  - c) Adding the new layer of grades for support group category, i.e. from 17-40 to 17-26 and 27-40.





















### 3. DECISION

- 3.1 The Staff Service Committee (SSC) Meeting No. 4/2022 held on 22<sup>nd</sup> December 2022 approved as follows:
  - i) The adoption of the Treasury Circular No. 1PP WP 1.10 (Revision effective on 1<sup>st</sup> January 2022) with regards to the allowance eligibility while attending courses in totality, subject to financial capabilities of the University.
  - ii) The above revised rate is to be extended to other schemes of service established by IIUM in accordance to the relevant equivalent grades, i.e. Academic Fellow, Research Fellow and Clinical Nursing Instructor.
- 3.2 The effective date of implementation is 1st January 2023.
- 3.3 With the issuance of this circular, the MSD Service Circular No. 17/2020 is superseded.

All Deans/Directors are kindly required to disseminate this information to all relevant staff at the Kulliyyah/Centre/Division/Institute/Offices/Mahallahs.
