STAFF SERVICE CIRCULAR NO. 15/2024

ESTABLISHMENT OF DEPUTY PRINCIPAL POST FOR MAHALLAH AT IIUM KUANTAN CAMPUS

1. OBJECTIVE

The objective of this circular is to notify all Deans/Directors of the Kulliyyahs / Divisions / Centres / Institutes / Offices / Mahallahs pertaining to the establishment of Deputy Principal post for Mahallah at IIUM Kuantan Campus.

2. BACKGROUND

- 2.1 The residential college for students at the International Islamic University Malaysia (IIUM) is referred to as Mahallah. Currently, IIUM Kuantan ensures full-time undergraduate students receive 100% accommodation. The Mahallah at IIUM Kuantan Campus with a capacity of 5000 began its occupancy on 26th October 2014 and the Private Finance Initiative (PFI) contract agreement is scheduled to conclude on 25th October 2034.
- 2.2 Currently, the administration of the Mahallah Management falls under the leadership of the Principal, which is within the purview of the Deputy Campus Director (Student Development & Support Services), IIUM Kuantan Campus. As of Semester 1, 2023/2024 Session, the Mahallah has a total of 3,560 registered students, comprising of 984 male and 2,576 female.























2.3 The current composition and ratio of Principals and Fellows of Mahallahs at IIUM Kuantan Campus for the Year 2023 are as follows:-

- 2.4 In view of the capacities of the three (3) Mahallahs in IIUM Kuantan Campus, the Campus Director has submitted a proposal on the Establishment of New Deputy Principal Post for Mahallah, IIUM Kuantan Campus. The announcement of this decision was made by the Campus Director during a meeting with the Mahallah Management of IIUM Kuantan Campus on Monday, 7th December 2023.
- 2.5 The above proposal was tabled in the University Management Committee (UMC) Meeting No. 2/2024 on 24th January 2024. The UMC decided for the proposal to be tabled in the Student Affairs Committee (SAC) meeting prior to submission to SSC for approval. The proposal and its recommendation was further discussed in the SAC Meeting No. 1/2024 held on 8th March 2024 prior to submission to the Staff Service Committee (SSC) for approval.
- 2.6 The justifications for the new Deputy Principal post are as follows:
 - i) The proposed unified structure featuring one (1) Principal and one (1) Deputy Principal overseeing three (3) Mahallahs represents a new structure for IIUM. Currently, each of the three (3) Mahallahs is independently overseen by a respective Principal. Thus, this strategic move aligns with the lean management principles implemented for IIUM Kuantan Campus.
 - ii) A comparative survey has been conducted on Hostel Management among Higher Education Institutions (HEIs) in Malaysia and the appointment of Director and Deputy Director of Hostel.
 - iii) The new structure for year 2024 would contribute to the cost saving of RM12,960.00 per annum from the University budget per Mahallah for Principal and Deputy Principal post.
- 2.7 The new composition and ratio are as detailed below:-

3. DECISION

- 3.1 The Staff Service Committee (SSC) Meeting No. 3/2024 held on 11th June 2024 approved the establishment of Deputy Principal post for Mahallah at IIUM Kuantan Campus.
- 3.2 The effective date of implementation of the establishment of Deputy Principal post is 1st July 2024.
- 3.3 The SSC also approved the revised Guidelines for Principal, Deputy Principal, Fellow and Resident Fellow Management as recommended by the SAC, which is provided in *Appendix A*.
- 3.4 Following the above decisions, the MSD Service Circular No. 16/2022 and Staff Service Circular Letter No. 3/2023 are superseded.
